## Rules Concerning Disqualification Due To Misconduct

It is a **condition of entry** that this form be clearly named, signed and attached to the competition entry form

(See 'WDFPF Rule Book 2011" pg 22. Section 'VII. CONDUCT OF COMPETITION')

**M. RULES CONCERNING DISQUALIFICATION DUE TO MISCONDUCT:** Any lifter or coach, who by reason of misconduct on or near the competition platform which is likely to discredit the sport, shall be officially warned. If the misconduct continues, the Jury (or referees, in the absence of a Jury) may disqualify the lifter and order the coach to leave the venue. The team manager must be officially informed of both warning and disqualification.

SA Drug Free Powerlifting Assoc. Inc. deems 'Misconduct' (at or in the competition venue) to be:

- 1) Bullying.
- 2) Loud, aggressive or intimidating behaviour.
- 3) Foul language (indecent or profane language).
- 4) Failing to treat the referees or any officials with absolute respect.
